The national holiday of Japan and Oman is closed.

<Consul Procedure>

- It is necessary to sign the autograph of the chamber of commerce and industry respectively as a commercial invoice and certification of country origin etc. Moreover, both documents describe both following content; "We hereby certify that the above good are of Japanese origin."
- 2. It takes two days to issue the visa legalization.
- 3. The visa application by mailing is improper. The representation application is possible.
- 4. When the commercial invoice becomes page more than 2, it is necessary to prove the chamber of commerce and industry to the page to which the sending total, the manufacturing total, and the manufacturer's name can be described.
- 5. The commercial invoice and certificate of country origin proof both manufacturer's names and addresses are described.
- There is a prescribed procedure for others the above-mentioned, the agency contract, the consignment contract, and the dealings contract, etc.
 Please inquiry to the Embassy.
- 7. One copy for the embassy is prepared besides for application. (exception: Invoice & Certificate of Origin)

1. Receive the attestation at the notary public's office, Ministry of Foreign Affairs or the chamber of commerce and industry beforehand when you receive the attestation of the document related to the contract.

<Import permission>

The import permit is unnecessary excluding the article with the obstacle on the religion or military affairs.
