

# **The Japan-Australia Business Co-operation Committee**

## **Background to establishment**

In March 1961, the Tokyo Chamber of Commerce and Industry (TCCI) sent a trade goodwill mission to Australia, led by TCCI Vice Chairman Mr Shigeo Nagano, who was also the president of Fuji Steel Corporation. During their visit to Canberra, Mr Nagano proposed the establishment of a business co-operation committee with the aim of contributing to the development of Japan-Australia economic relations by promoting mutual understanding and cooperation between the two countries' business communities.

In response to this proposal, the Japan-Australia Business Co-operation Committee (JABCC) was established in February 1963 on the Japanese side under the leadership of the Japan Chamber of Commerce and Industry (JCCI), Keidanren (the Japan Business Federation), the Japan Foreign Trade Council (JFTC), and the Japan External Trade Organization (JETRO). Meanwhile, on the Australian side, the Australia-Japan Business Co-operation Committee (AJBCC) was established in August 1962 by the Associated Chamber of Manufactures of Australia (ACMA) and the Associated Chamber of Commerce of Australia (ACCA). In May 1963, the first Japan-Australia Joint Business Conference was held in Tokyo.

## **(1) Major Activities of the JABCC**

### **Japan-Australia Joint Business Conference**

The conference brings together the top business leaders and government officials from both countries to discuss a wide range of topics focused on trade and investment that are fitted to the times, and to make recommendations to the governments of both countries as necessary. The conference is held alternately every year in the two countries.

The conference has made requests to the governments to improve issues related to the business environment, and has achieved significant results. Examples include actions on sugar issues and iron ore issues, the opening of the Perth Consulate-General, the implementation of the Australia-Japan EPA/TPP, and improvement of work visa requirements in Australia.

8–10 October 2023

The memorable 60th Australia-Japan Joint Business Conference was held in Melbourne. The hosts, Mr Grey, President of the AJBCC, and Mr Hirose, Chairman of the JABCC welcomed guests including Mr Yasutoshi Nishimura, Minister of Economy, Trade and Industry; Senator the Hon Don Farrell, Minister for Trade and Tourism, Special Minister of State; and the Hon Chris Bowen MP, Minister for Climate Change and Energy. A total of 728 business leaders from Japan and Australia attended this conference and celebrated the partnership between the two countries.

## **Steering Committee**

This committee considers issues that have medium- to long-term impacts on the bilateral commercial relationship, and also examines global issues. Meetings are usually held in October and March. The meeting in October is held on the day before the opening ceremony of the Joint Business Conference. The meetings in March are held via teleconference. (The committee consists of 22 Executive members: 1 Chairman, 3 Vice Chairmen, 15 Committee Members, and 3 Advisors.)

## **FLP: Future Leaders Program**

This program is designed to develop future business leaders in the two countries. Members of the program include young business people and others active in cultural affairs. The program supports the Australian government's New Colombo Plan (which includes an internship program for Australian university students in Japan), organizes personnel exchanges and seminars, participates in joint conferences, and publishes a booklet on Japan-Australia business.

October 2022:

Published a booklet titled *Australia & Japan: Beyond the Bilateral – Investing in infrastructure projects across the Indo-Pacific*, which identifies issues and proposes solutions for collaboration between the two countries in infrastructure projects.



## **JABCC Committee on the Promotion of EPA Utilization**

Further to the Japanese and Australian Government's joint establishment of the "Sub-committee on Promotion of a Closer Economic Relationship," the JAEPA Implementation Sub-committee was established in June 2015 in order to provide the industry with a forum for exchanging views and examining new business opportunities as a result of the entry into force of the Japan-Australia Economic Partnership Agreement (JAEPA).

##### **Meeting with Prime Minister Scott Morrison**
