II. Procedures for Invoice & Certificate of Origin Applicants (インボイス・原産地証明書)

1. Authentication by the Chamber of Commerce and Industries

Commercial invoices and certificates of origin must be authenticated by the Chamber of Commerce and Industries. Please be reminded that we <u>DO NOT</u> accept rubber seals, but the seal has to be a handwriting signature. However, for the sake of smooth procedures, we only accept rubber seals of the Chamber of Commerce of <u>Tokyo</u>, <u>Osaka</u>, <u>Nagoya</u>, <u>Kobe</u>, <u>and Takasago</u> as exceptions. We also accept rubber stamps from the Chamber of Commerce and Industries of Korea.

Please check the following items on **BOTH** the commercial invoices and certificates of origin

- 1. Seals of the Chamber of Commerce and Industries
- 2. The consignee address in Syria.
- 3. Declaration "We hereby certify that the goods are not of Israeli Origin, that they do not contain any Israel materials and that they are not being exported from Israel" is clearly written.
- 4. The same invoice number and date.

2. What to Bring to the Embassy

- 1. An original commercial invoice and a certificate of origin. (Please staple them)
- 2. A copy of both a commercial invoice and a certificate of origin. (Please stable them)
- A small note indicating the contact information of a company and you may calculate
 the application fee in advance and mention it. (Calculation formula for invoice fee
 is written below)

Please be reminded that we <u>DO NOT</u> accept rubber seals, but the seals have to be handwriting signature. However, for the sake of smooth procedures, we only accept rubber seals of the Chamber of Commerce of <u>Tokyo, Osaka, Nagoya, Kobe, and Takasago</u> as exceptions. We also accept rubber stamps from the Chamber of Commerce and Industries of Korea.

- 2. Any sentences or phrases indicating Syria
